Temporary Food Facility (TFF): Vendors will need to purchase a temporary health permit from the City of Long Beach Environmental Health Services. Temporary Food Facility vendors will also need to provide their own 3-compartment sink, or pay an additional fee of \$150 per event for Beach Ventures Enterprises to provide this item. Please note: If you cook on an open-flame firepit, you will need to pay for an additional 5 feet of space at \$150.00 as your firepit is required to be 10 ft. fom your an preparation facility.

Merchandise/ Arts and Crafts Vendors: Beach Ventures Enterprises will not collect a percentage fee or commission on any sales; all proceeds go to the vendors. All vendors shall be responsible for collecting and reporting taxes and are required to possess their own State Board of Equalization Seller's Permit. Your original seller's license **must** be displayed in your booth A copy of your seller's license **must** be provided along with your Booth Application.

We remind vendors that our community is very family-oriented. We do not allow any drug-related items or items of a risqué nature sold at our events. BVE reserves the right to prohibit the sale of any item.

Parking: BVE will provide each vendor with a **SINGLE PARKING PASS** (**ONE VEHICLE FOR EVENT DAYS ONLY!**) for each 10 X 10 space rented.
